

### NOGALES UNIFIED SCHOOL DISTRICT NO. 1 **GOVERNING BOARD**

Minutes of the Study Session of July 13, 2020 held at 2:00 p.m.

#### Attendance:

The following Board Members were present:

Dr. Marcelino Varona, Jr., President, Greg Lucero Clerk; Members Robert Rojas and Manuel Ruiz

a. Call to Order

Dr. Varona called the meeting to order at 2:00 p.m.

b. Pledge of Allegiance

Mr. Colgate led all in the Pledge.

Adoption of the Agenda

Superintendent Parra recommended approval as presented.

Mr. Ruiz made a motion and was seconded by Rojas for approval.

Motion carried unanimously by members: Ruiz, Rojas, Lucero and Varona

#### **Study Session** 11.

a. Update and Presentation Reopening of Schools Plan-ONLINE ONLY August 5, 2020 (Decisions/Recommendations on "IF" Schools Will Reopen-In-Person with Other Models of Instruction Based on the Data)

Superintendent Parra thanked all the people in the committee who were part of the decision-making on the reopening of the schools. He mentioned the Online Plan to reopen the schools on August 5, 2020.

He further gave an updated report on the re-opening of the schools cleaning and disinfecting guidelines to return physically to the classrooms.

Reopening of Schools Plan

Angel Canto, Asst, Superintendent, gave a Power Point presentation with a brief review of the data related to the re-opening of the schools that included the surveys received from the community and District employees.

Ms. Canto, in connection with the plan, read the NUSD Resolution for re-opening the schools.

Dr. Varona inquired regarding the Power Point not having been distributed to the Board before the meeting.

Superintendent Parra explained this was an ongoing plan and had not been finalized and the District felt more comfortable awaiting for the final draft.

Dr. Varona stated he did not have time to study and would participate in the decision making until full clarification was made.

Mr. Lucero expressed his concerns to re-opening the schools, stating he as well as Dr. Varona did not feel prepared to make a decision without all the information on hand.

Mr. Ruiz mentioned that this information gave an idea of how the parents feel and based on that information the Board needed to be proactive in making a decision at this time.

He added that the plan needed more dialogue to assure that there will be a safe school to attend physically but the Board needed to trust the administration and committee and await the final plan.

## At 2:30 p.m., Dr. Varona acknowledge that Mrs. Mendoza had joined the meeting.

Mr. Rojas mentioned about the possible consideration of a year-round school program in order to create a break in between to be able and sanitize the schools more often.

He further agreed with the Board on getting more information on the full plan but added that he felt the information given was a good start.

Superintendent Parra thanked the Board for their feedback. He stated that he would reschedule another Study Session to bring back updated information.

Mrs. Mendoza mentioned that due to not having been on time for the presentation, she had no comments at the time.

Mr. Parra continued explaining that the committee's direction was a brief plan. He further mentioned that in connection, there was a deep plan from Food Services as well and they are awaiting the direction they will take.

Furthermore, he mentioned that the cleaning and sanitizing staff have received training and it will be included in the plan for re-opening.

He mentioned that the plan and structure would be reported to the Board. He further mentioned that the committee had discussed year-round schooling, and was not something they would consider due to the instructional time required.

Superintendent Parra asked if they could revisit and reschedule another Study Session at an agreed time.

Dr. Varona recommended Monday July 20, 2020 or July 27, 2020.

Mr. Lucero suggested having the Board's questions submitted ahead of time before the meeting in order for the Superintendent to have better knowledge of what the Board's concerns are. Dr. Varona added that any scientific data would be greatly appreciated.

Dr. Varona stated he would not table the Resolution at the Regular Meeting.

Update on AIA/Arizona Interscholastic Association/Principal - Tim Colgate

Superintendent Parra introduced Mr. Colgate to give a Power Point presentation.

Mr. Colgate gave a Power Point presentation of what plan AIA is looking at right now on the timeline for reopening sports.

Mr. Rojas thanked Mr. Colgate mentioning it was thorough and a good presentation.

Mr. Lucero thanked Mr. Colgate for a good presentation.

Mr. Ruiz stated that he was glad they were following CDC guidelines, and recommended that when athletes go back to practice in this heat that they be careful with the use of masks and their breathing to avoid casualties. He thanked Mr. Colgate for a good presentation.

Mrs. Mendoza thanked Mr. Colgate for the good information presented and guidelines to follow.

Dr. Varona confirmed a July 27, 2020 at 2:00 p.m., Study Session to give an updated report and a printed presentation sent to the Board.

#### b. FY21 School District Annual Expenditure Budget

Superintendent Parra gave a brief update and turned the meeting to Mr. Sandoval to give a presentation.

Mr. Adelmo Sandoval, Business Director, gave a Power point presentation of the FY21 Expenditure Budget.

Mrs. Mendoza thanked Mr. Sandoval for the presentation and always working hard to keep the District compliant.

Mr. Lucero mentioned and thanked Mr. Sandoval for a very good presentation and being conservative.

Mr. Ruiz thanked Mr. Sandoval for the good presentation and further acknowledged, this was to serve better the students.

Mr. Rojas thanked Mr. Sandoval for a good presentation.

He concluded by stating that thing to name was the need of more money to build more schools.

Dr. Varona concurred with his colleagues and thanked Mr. Sandoval for making sure the funds are going to the classrooms. He further mentioned that the safety of the students is number one.

Mr. Parra thanked the Board's openness with their comments and mentioned that the Team would be guided by the data and science as requested by the Board.

Dr. Varona explained in more detail and clarified his concern.

Motion carried unanimously with roll call vote of "yay" by members: Ruiz, Mendoza, Rojas, Lucero and Varona

#### VIII. Requests for Future Agenda Items

Mr. Lucero asked for potential future discussion on a possible virtual welcome back for District employees.

Dr. Varona welcomed Mr. Givlin again and stated he was looking forward to a good academic year.

#### IX. Adjournment

Mr. Rojas made a motion and was seconded by Mr. Ruiz for adjournment of the public meeting.
